RESOLUTION 2012-09

RESOLUTION OF THE BOARD OF DIRECTORS OF THE BIG BEAR CITY COMMUNITY SERVICES DISTRICT ESTABLISHING THE APPROPRIATIONS LIMIT FOR FISCAL YEAR 2012-13

WHEREAS, Article XIIIB of the California Constitution places an annual limitation upon appropriations from proceeds of taxes by each local government of the State of California; and

WHEREAS, Section 7910 of the California Government Code implements Article XIIIB of the California Constitution by requiring each local jurisdiction to annually establish, by resolution, its appropriations limit for the fiscal year, and to make the documentation used in determining the appropriations limit available to the public 15 days prior to adoption of the resolution establishing the appropriations limit; and

WHEREAS, this District's Financial Analyst has documented the calculations of the District's appropriations limit for fiscal year 2012-13, and said calculations were posted on the District's bulletin board and made available to the public on June 21, 2012 and have been available since;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Big Bear City Community Services District as follows:

- 1. The method selected for the annual inflation adjustment factor is the percentage change in California per capita personal income.
- 2. The method selected for the annual population adjustment factor is the percentage change in population within San Bernardino County.
- 3. The appropriations limit applicable to this District pursuant to Article XIIIB of the California Constitution for fiscal year 2012-13 is hereby established and determined to be the sum of \$5,547,848.
- 4. A copy of the documentation used in the determination of the 2012-13 appropriations limit is affixed hereto and shall be available for public inspection.
 - 5. This resolution shall take effect immediately upon adoption.
